THE POLICY FOR DIFFERENTLY ABLED PEOPLE

The Government of India has enacted three legislations for persons with disabilities: Persons with Disability (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995, which provides for education, employment, creation of a barrier-free environment and social security etc. Keeping in view with the guidelines given by the National Disabled Policy and University Grants Commission, our Institution treats people with disabilities as valuable human resources. The college aims at creating and developing special education activities, a barrier-free environment, and an infrastructure that empowers differently abled persons.

Preamble: -

This policy document is recognized as the "Policy for Differently abled People" of the Bherulal Patidar Govt. P.G. College, Mhow

Objectives: -

- 1. To ensure the application of laws pertaining to individuals with disabilities.
- 2. To ensure entry into the open quota or reserved space designated for them.
- 3. To provide them scholarships, free ships, and concessions in accordance with the law.
- 4. To provide a welcoming atmosphere on campus.
- 5. To avoid prejudice and exploitation by fostering a culture that is inclusive of people with disabilities.
- 6. To make changes to the infrastructure to improve these pupils' accessibility and mobility.
- 7. Facilities such as classrooms, restrooms, and ramps ought to be built with the needs of people with physical disabilities in mind.
- 8. To provide wheelchairs at their disposal.
- 9. To establish a counseling center that helps people select the right path toward employment.
- 10. Braille and audio books for students with visual impairments should be available in the library. To organize awareness and training programs for faculty, members and office staff to sensitize them to such issues.






- 12. Facilities that are to be given by the Exam Department: -
 - (i) Scribes are provided to visually impaired and physically challenged students (on request) to write the examination and extra time is given as per the rules.
 - (ii) To facilitate the visually impaired people with screen reader facilities.

Committee: -

A committee is constituted for the effective implementation of the Differently abled policy, which is as follows:



Role and responsibility of the committee: -

The Committee should ensure proper services to the Differently Challenged and ensure their effective implementation.
